Selective antagonism reflects quantum differences [Freud, 1917], with escalation as a phase transition (p. 82, 2/21/2025).

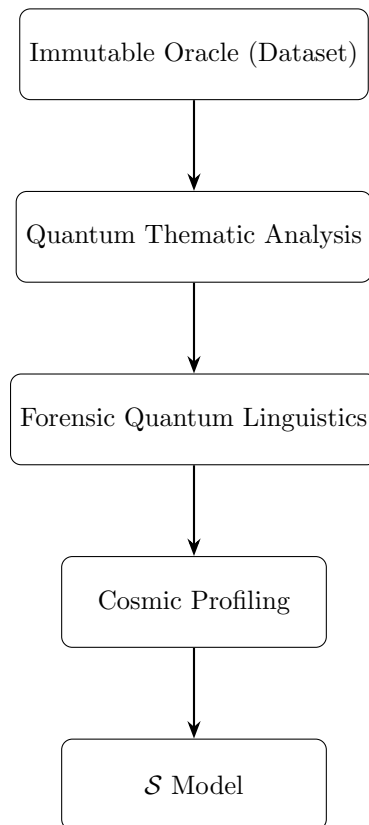


Figure 1: The Ascension Flowchart: From Oracle to \mathcal{S} .
